## National Rural Electric Cooperative Association Youth Tour Program

Program winners will attend the NRECA Youth Tour in Washington D.C.  
June 2012

### Program Objectives

- To educate rural youth about cooperative principles.
- To educate youth in the principles and practices of the American democratic system.
- To promote rural electrification and educate youth about rural electric cooperatives.

### Eligibility

- To be eligible to compete:
  1. The student must be a high school junior.
  2. The student or their parents or guardians must be Big Bend Electric Co-op members at the time of application and selection.
  3. The student must be receiving good grades, have a neat appearance, and be able to get along well with other people. Verification of grades needs to be signed by your school counselor.

### Applications

- The Co-op will provide information packets and applications to eligible students either through school counselors or through Big Bend Electric Co-op.
- Interested students must submit applications by the **deadline date of January 6, 2012.**
- Along with their application the student must submit a 500-650 word essay on a topic selected by Big Bend Electric Co-op.
- There will be five finalists chosen for the interview process. Interviews will be scheduled for the week of January 23, 2012. Following the interview of these five, two finalists and one alternate will be selected. The finalists will represent Big Bend Electric Co-op as representatives of the Washington state delegation at the 2012 NRECA Youth Tour in Washington D.C. If a finalist is unable to make the trip, the alternate will take their place.

### Application Evaluation

- Essay 30%
  - Scholastic Record 20%
  - School, Community, & Leadership Activities 25%
- The five highest scoring students will reach the interview process
- Interview 25%

### Youth Tour Winners

- Will attend the Big Bend Electric Co-op annual meeting in February in order to be introduced to its members.
- Travel to Washington D.C. to attend the NRECA Youth Tour in June 2012.
- Compete against other state of Washington participants at the DC Youth Tour to be chosen as the Washington representative to the following year's NRECA annual meeting.
